The Board of Trustees met in special session on Wednesday, May 7, 2025, in the 2nd Floor Conference Room at the Downtown Newark Library. Will McCoy called the meeting to order at 12:06 p.m. The following trustees answered the roll call: Lacie Priest, Debbie Seibel, Brian Wilfong, and Will McCoy.

Mr. McCoy announced the resignation of Licking County Library Board of Trustees member Mrs. Kathy Myers. Mrs. Myers served as a member of the Board from September 1, 2008. Mrs. Myers has served on multiple committees and provided expertise and insights that improved the Library's fiscal practices and controls.

<u>Lakewood Branch Project Award of Contract</u>

Mr. Will McCoy introduced the following resolution and moved its passage:

Resolution No. _025-036____ AWARDING CONTRACT FOR THE NEW LAKEWOOD BRANCH PROJECT

WHEREAS, the Licking County Library Board of Trustees (the "Board") is undertaking the New Lakewood Branch Project (the "Project"); and

025-035 Approval of Regular Business Meeting Minutes WHEREAS, the Board previously authorized the solicitation of bids for the Project pursuant to Ohio Revised Code Section 3375.41 and such ad is attached hereto; and

WHEREAS, three bids were received on April 29, 2025, and publicly opened and read aloud by the Fiscal Officer in the Discovery Center, immediately after the time for submitting such bids had expired; and

WHEREAS, Schooley Caldwell is the Design Professional for the Project and tabulated the bids that were received, and such bid tabulation is attached hereto; and

WHEREAS, the apparent lowest bid was submitted by T-Built Construction Services, Inc. ("T-Built"); and

WHEREAS, Schooley Caldwell reviewed the bid submittal, contacted references, and recommends awarding the contract for the Project to T-Built, as the lowest responsible bid that is responsive, in the total amount of \$541,740.00, including Alternate No. 1; and

WHEREAS, during construction of the Project, there may be changes to the Work that impact the Scope of the Work, Contract Sum, and/or Contract Time. These changes may be documented via Amendment, Change Order, or Construction Change Directive ("Modifications") and to avoid Project delay and related costs, the Executive Director or Fiscal Officer may be authorized to approve and execute such Modifications which shall not individually exceed the amount of \$10,000.00 and shall not cumulatively exceed the amount of \$25,000.

NOW, THEREFORE, BE IT RESOLVED by the Licking County Library Board of Trustees as follows:

- The Board approves the bid opening and, based on Schooley Caldwell's recommendation and information provided, awards the contract for the Project to T-Built, as the lowest responsible bidder for the work.
- The Board authorizes the Executive Director and Fiscal Officer to sign the contract with T-Built in the total amount of \$541,740.00, including Alternate 1, and to prepare and sign any related documents required for the Project.
- 3. The Board further authorizes the Executive Director or Fiscal Officer to sign Modification(s) related to the Project where such Modification individually does not exceed \$10,000.00 or cumulatively exceed \$25,000. Should a Modification exceed this individual or cumulative amount, it will be brought to the Board for approval.

Mr. Brian Wilfong seconded the motion and, after discussion, a roll call vote was taken and the resolution passed.
